

Warranty

Definitions

References to “**WW**”, “**we**”, “**us**”, and “**our**” represent Walker Woodworking Inc. and/or the staff of Walker Woodworking Inc.

Walker Woodworking, Inc (WW) warrants to the original consumer purchaser that all products WW sells will be free from defects in material and workmanship under normal use for as long as he/she owns the home in which the WW products are originally installed. This warranty is only applicable to WW Products used in personal residences located within the United States and is not transferable to subsequent owners. WW may require Proof of Purchase. Should defects in material or workmanship exist during the applicable warranty period in any WW product, WW will elect at its discretion to either repair or replace the defective material or component, free of charge. This warranty is expressly limited to repair or replacement of the defective part at WW’s discretion and does not include labor for removal or replacement, or for other expenses such as the cost of removal, transportation, re-installation, overtime labor, etc. This warranty covers only parts and materials of WW products. This warranty does not cover countertops, appliances, plumbing fixtures, backsplashes, flooring, etc. or the costs, including labor, to remove and reinstall such items and related components such as fittings, appliances, etc.

This warranty shall become void if the cabinets are in any way modified. Furthermore, this warranty does not cover damage resulting from normal wear and tear, accident, misuse, abuse, dirt, water, tampering, unreasonable use, neglect, acts of God, and exposure to extreme temperatures, or servicing performed or attempted by unauthorized service agencies, or for units that have been used for commercial purposes.

All wood varies in color and characteristics, and shows changes as it ages. Sunlight, smoke, household cleaners, and other environmental conditions may also affect the color match over time. These variations are considered to be the nature of the material in relation to environmental exposure and are not covered under this warranty. Paint and primer finishes tend to emphasize natural variations in the surface of the wood such as grain depressions, grain waves, and open cellular structure. Hairline cracks may become visible at assembly joints.

WW reserves the right to alter design, specifications, and material without obligation to make similar changes to products previously manufactured. If components are replaced, WW cannot guarantee that the finish of these replacements will exactly match the finish and appearance of the components in the residential application. This is due to the changes that occur during the wood's natural aging process, affecting its color and grain.

Installation prior to HVAC humidity control, moisture, sunlight, smoke, household cleaners, and other environmental conditions may cause the materials to vary from their original color and to warp, split, or crack. These variations are considered to be natural and related to the environmental exposure of the product and are not covered under warranty.

IN NO EVENT SHALL WW BE LIABLE FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES TO THE PURCHASER OR ANY THIRD PARTY, INCLUDING, WITHOUT LIMITATION, DAMAGES ARISING FROM PERSONAL INJURY, LOST PROFITS, LOSS OF BUSINESS

OPPORTUNITY, LOSS OF PROPERTY, ECONOMIC LOSSES, OR STATUTORY OR EXEMPLARY DAMAGES, WHETHER FROM NEGLIGENCE, WARRANTY, STRICT LIABILITY OR OTHERWISE.
